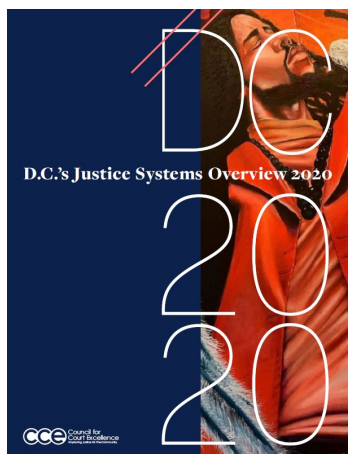

New Report Highlights Developments & Challenges in D.C.'s Criminal Legal System

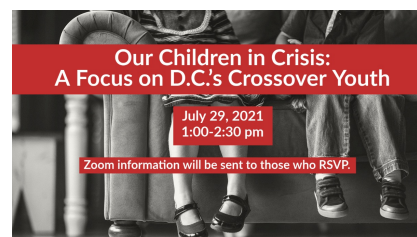
On May 11, CCE published [D.C.'s Justice Systems Overview 2020](#), our newest data-driven review of the most significant challenges in the District's adult and youth criminal legal systems and progress over the last 18 months. The report, supported by the Public Welfare Foundation, builds off of the 2019 inaugural edition, [D.C.'s Justice Systems Overview](#), and concentrates on five areas: Violence and Policing; Adult Prosecution and the Courts; Incarceration; Reentry; and Youth Justice. Forums Discuss Future of Policing in D.C. & Impacts of Local Control on Statehood

CCE hosted the first two of four roundtable discussions on May 4 and June 30. Both panels were moderated by **D.C. Auditor Kathy Patterson**. During the first forum, "The Future of Policing in the District," panelists discussed alternatives being implemented by other jurisdictions, reforming the police recruitment and training process, and recommendations from the [D.C. Police Reform Commission](#). Kenithia Alston, mother of Marquese Alston and activist, spoke on her fight to receive unedited police bodycam footage of her son's death: "I am advocating, protesting at the front line, and grieving all at the same time." The second forum, "What If We Were In Charge?", was a lively conversation about the future of D.C.'s criminal legal system with more local control or D.C. Statehood. Panelists discussed how a lack of control impacts D.C.'s ability to hold agencies accountable, as well as many reforms that can and should be enacted now. You can watch the full discussion [here](#). CCE Calls for More Transparency in Court of Appeals Decisions

Continuing our calls for transparency and reliable access to court records, CCE submitted a [public comment](#) in April encouraging the D.C. Court of Appeals to provide public access to court electronic records. The comment highlighted the importance of online access in the digital age in order to ensure public monitoring and oversight of the legal system. CCE's comment stems from our 2017 report, [Remote Public Access to Public Records: A Cross-Jurisdictional Review for the D.C. Courts](#), which examines the best means for state and federal courts to provide public access to court records. CCE remains committed to the principle of court and agency transparency to ensure that the public is well-informed and equipped to make important legal decisions. Community Presentations on Phase II Task Force Recommendations

Throughout the spring, the District Task Force on Jails & Justice members and CCE staff have facilitated over 24 community presentations and "teach-ins" in D.C. on the Task Force's Phase II report, [Jails & Justice: Our Transformation Starts Today](#). The report makes 80 recommendations to help D.C. invest in safer communities and cut local incarceration rates in half. During the presentations, Task Force members shared correctional and survey data, identified priority recommendations, answered questions, and discussed ways for community members to get involved in advocating for reform. CCE thanks the Task Force members who volunteered their

time and expertise to present to more than 750 community members!

CCE Board Leaders & Staff Testify Before D.C. Council

This summer, CCE staff and Board leaders testified six times before D.C. Council. CCE staff and Board Leader **Jonathan Jeffress** testified at the [Criminal Record Sealing and Expungement Public Hearing](#) in April and again in May at the [Public Oversight Roundtable on Local Control of Parole](#), calling for the establishment of a new parole authority to make parole grant, parole and supervision revocation, and early termination decisions. Additionally, CCE testified at or submitted testimony for the FY22 Budget Oversight Hearings for the [D.C. Department of Behavioral Health, Office of Victim Services and Justice Grants](#), [D.C. Department of Transportation](#), [Office of Administrative Hearings](#), and the [Office of Human Rights](#).

Op-Ed From CCE Executive Director Published in the *Washington Post*

On July 19, 2021, the *Washington Post* published ["D.C. needs a local paroling authority."](#) an op-ed by CCE's Executive Director **Misty Thomas**. In the article, Ms. Thomas calls for greater urgency from D.C. leaders to make policy decisions and budgetary investments to support a locally-controlled paroling authority. Without action now, D.C. will likely fail to meet Congress's November 2022 deadline to sunset the U.S. Parole Commission's authority over D.C. cases.
