The Silbert Fellowship is named for Earl J. Silbert, former president of the Council for Court Excellence, and is awarded to an individual studying at the graduate level who demonstrates a passion for improving the justice system as exemplified by Mr. Silbert throughout his career.

ABOUT EARL J. SILBERT

Earl Silbert has had a distinguished legal career in the District of Columbia for more than 50 years. Long recognized as one of the premier members of the white collar criminal bar in the District of Columbia, his career has spanned public service, private practice, and voluntary service to the courts and legal profession. He has mentored and advised many attorneys throughout his career and is highly regarded for his wisdom, decency, graciousness, and professionalism. Prior to entering private practice, Mr. Silbert spent nearly 20 years in government service at the US Department of Justice in the Tax Division and Deputy Attorney General's Office, as an Assistant US Attorney, and as US Attorney for the District of Columbia (1974-79). While in the US Attorney's Office, he, together with two other Assistant US Attorneys, served as the first Watergate prosecutor.

In 2009, the Council for Court Excellence honored Mr. Silbert with the Justice Potter Stewart Award for his career-long work to improve the justice system. That same year, he was elected president of the Council for Court Excellence. He is currently a partner at DLA Piper LLP (US) in Washington, DC. He is an alumnus of Harvard University and Harvard Law School.

THE FELLOWSHIP (ONE POSITION FOR SUMMER 2017)

The Council for Court Excellence seeks candidates who share CCE's mission to improve the justice system in the District of Columbia. The fellowship offers hands-on experience to exceptional graduate-level students planning a career in law or public policy with opportunities to:

- Strengthen their understanding of DC's justice system;
- Participate in the reform of local and federal justice system policies and practices affecting the jury system, civil case processing, administrative justice, and criminal and juvenile justice, among other issues;
- Improve, through educational programs and publications, the public's understanding of and ability to navigate DC's justice system; and
- Work with a dedicated staff and volunteer board of lawyers, business leaders, judges, and civic leaders in an environment that is collaborative and intellectually rigorous.

GENERAL RESPONSIBILITIES

The Silbert Fellow will be engaged in substantive project work, including:

- Primary and secondary research of the local and federal justice systems' and associated agencies' policies and practices;
- Creating public education guides to help the public navigate various aspects of DC's justice system;
- Developing local and federal legislation pertaining to DC's justice system;
- Providing support to the various project committees through attending meetings, researching project leads, etc.; and
- Assisting with report release events and other program-related events as needed.

ELIGIBILITY AND QUALIFICATIONS

Graduate and law students are eligible for the Silbert Fellowship. Applicants should have experience in policy or legal research and interest in one or more of the following areas: public policy, law, government, courts, criminal justice, civil justice, or administrative justice.

COMPENSATION AND DURATION

The Silbert Fellow will receive a stipend, thanks to the generosity of DLA Piper LLP (US). CCE will cover local public transportation costs. The fellowship is full time (37.5 hours/week), and CCE requires a minimum commitment of 10 consecutive weeks. The start date is somewhat flexible, but CCE expects the Silbert Fellow to begin in late May or early June.
