### District Task Force on Jails & Justice Releases Report to Transform D.C.'s Justice System

On February 11, 2021, the **District Task Force on Jails & Justice** published its final report, [Jails & Justice: Our Transformation Starts Today](#) which includes 80 recommendations to improve the criminal justice system in D.C. and to lower incarceration rates by half. Based on research and drafting support from CCE, the new report provides District leaders with a roadmap for implementing a range of changes to laws, policies, and public investments. The recommendations are designed to reduce D.C.'s incarcerated population and enhance community safety, with a specific focus on ending the justice system's disproportionate negative impacts on Black residents. CCE facilitated a [virtual launch event](#) where Task Force members, including Chair **Shelley Broderick**, discussed their recommendations and how D.C. can change the criminal justice system with some immediate changes, and others over the

course of 10 years.

Since its release last month, there has been significant community interest in the Task Force's data and recommendations for reform. CCE has facilitated 12 educational briefings on the Task Force's report, reaching more than 1,000 D.C. residents and community stakeholders in the last month. Several more briefings are scheduled for April and May. ### Hosting the School Jury Education Program in a Virtual World

We look forward to learning from these first "trial runs" with our newly-adapted virtual SJEP curriculum and hosting additional class sessions in May 2021. We are especially grateful to the judges who volunteered and worked patiently with CCE and our partner, Street Law, as we navigated the challenges of hosting SJEP virtually for the first time.

We provided educational testimony regarding a range of issues facing D.C.'s justice system agencies, including: pre-arrest diversion, juvenile justice due process, our substance use disorder audit findings, and the District's Clemency Board, among

others. Additionally, CCE staff updated the Council and the public on the recent recommendations from the District Task Force on Jail & Justice's recent report.
